**Terms and Conditions for Exhibiting at
Leesport Farmers Market SPORTSMANS SHOW/ FLEA MARKET**

1. **Exhibitor Eligibility** - I (Ralph Reber) shall have the right to determine the eligibility for inclusion at the SPORTSMANS SHOW/FLEA MARKET, in accordance with its rules and regulations, and reserve the right to refuse any or all applications for table rental and to prohibit or remove any exhibit, display or part thereof, or proposed exhibit display or device which in my opinion is not related to the support of hunting, fishing, and the outdoor industry.
2. **Sub-Leasing and Sharing** - No exhibitor may assign sublet, or apportion the whole or any part of the exhibit space assigned nor permit any other party to exhibit therein, nor distribute any promotional or advertising materials in the occupied space other than those manufactured, displayed, or sold by exhibitor in the regular course of business.
3. **Exhibit Display Specifications** - Standard tables are 30" wide x 8' long and will be supplied w/an optional folding chair. If renting additional tables, they will be adjacent to each other. Items can be displayed on the floor beneath your table(s) but nothing shall be positioned on the floor or extend beyond the table which would impede the flow of the general public or hinder the Exhibitor adjacent or behind you. Exhibitor is responsible for keeping his/her area and surrounding area clean and professional looking. Exhibitor shall pay any repair damage to the Exhibit Facility caused by any action of the Exhibitor.
4. **Exhibition Schedule:** - Set up time for Exhibitors is 6:00am till 8:00am on Saturday February 11, 2012 (the day of the Show). The SPORTSMANS SHOW/FLEA MARKET hours are 8:00am to 2:00pm and all Exhibitors shall remain set up and open for business for that duration unless the promoter deems differently for some reason and announces a change that day. Exhibitors can initiate breakdown or start removing exhibit materials at 2:00pm (the day of the Show) and should try to be completed and out of the building by 4:30pm.
5. **Security** - There will be "NO SECURITY" provided by the promoter or Leesport Farmers Market during the day of the Show. The promoter (Ralph Reber or Ralph's Fishing, Hunting & Camping) and Leesport Farmers Market and or owners shall not be held responsible for the loss of any material by any cause and urges the Exhibitor to exercise precautions to discourage loss due to theft in the "exhibit area" at any time. Exhibitors are encouraged to insure exhibit property against loss or theft, and those wishing to do so, must do so at their expense.
6. **Insurance and Indemnity** - It is expressly understood and agreed by Exhibitor that neither the promoter (Ralph Reber or Ralph's Fishing, Hunting & Camping) and the Leesport Farmers Market and or owners, nor their employees shall be held liable for loss or damages to the goods or properties of the Exhibitor. On signing the EXHIBIT SPACE RENTAL AGREEMENT, Exhibitor releases and agrees to indemnify the promoter (Ralph Reber or Ralph's Fishing, Hunting & Camping) and the Leesport Farmers Market and or owners, and hold them harmless from any suite or claim from property damage or personal injury (including punitive damages) by whomsoever sustained, including Exhibitor and Exhibitors employees on or about Exhibitors display space or arising out of Exhibitor's participation in the SPORTSMANS SHOW/FLEA MARKET held at Leesport, expressly included such damage or injury resulting in any part of negligence of one or more of the aforementioned indemnities. The performance of this agreement by either party is subject to acts of God, war, government regulation, disaster, civil disorder, the public enemy, curtailment or transportation facilities, or other emergency over which neither party has control making it illegal or impossible to provide the facility to hold function. Exhibitor agrees to maintain such insurance that will fully protect the SPORTSMANS SHOW/FLEA MARKET from any and all claims of any nature whatsoever, including claims under the Worker's Compensation Act, and the Exhibitors display. Exhibitor agrees and indemnify and hold harmless the promoter (Ralph Reber or Ralph's Fishing, Hunting & Camping) and/or The Leesport Farmers Market and/or owners from such claims, irrespective of insurance coverage. Exhibitor further acknowledges that insurance covering the exhibit and/or property against damage and business interruption losses are the sole responsibility of the Exhibitor. In addition the Leesport Farmers Market and/or owners are not liable to Exhibitors for any damage to or for the loss or destruction of any exhibit or the property of Exhibitor by fire or other casualty by the extended coverage endorsement to a fire insurance policy, whether all claims for any such loss or damage being expressly waived by Exhibitor who agrees to indemnify and hold the host harmless for such claims.
7. **Cancellation/Disruption of the SPORTSMAN'S SHOW/FLEA MARKET** - Should any eventuality cause cancellation or disruption of the SHOW, the promoter (Ralph Reber or Ralph's Fishing, Hunting & Camping) shall not be liable for any expenses incurred by the Exhibitor. There will be "NO REFUNDS".
8. **Regulations** - All Exhibitors are responsible for there own dealings with federal, state, and local regulations.
